He has participated in several Track 1 and Track 1.5 dialogues, including India-U.S. and India-U.K. Strategic Intelligence Dialogues, after the 2008 Mumbai terrorist attacks. In 2019, he received the Australian government's prestigious Canberra Fellowship. His views on national security issues have featured in Moneycontrol, Business Insider, Indian Express and, Hindustan Times.

Dr. Raj Kumar Kothari has a Ph.D in political science from Mumbai University and has a teaching experience of nearly three decades and is currently the Professor of Political Science in Diamond Harbour Women's University. - This course endeavors to provide a basic overview of international relations, global trade, India's foreign policy vis-a-vis SAARC nations and Violent Non State Actors.
