- a) Candidate having PRN Number issued by the University, need to use the same and submit the print copy of filled-in Pre-admission Enrolment form.
- b) Candidate who do not have PRN No. issued by the University, need to create new registration on the link given and submit the print copy of Pre-admission Enrolment form.

- 2) Print copy of CET (LL.M.) Entrance Examination Result;
- 3) All Marksheets (all semesters including passed & failed) of qualifying examinations i.e. LL.B. (3 Year / 5 Year);
- 4) Graduation marksheets, if any;
- 5) HSC / Std. XII Mark sheet and Leaving Certificate;
- 6) SSC / Std. X Mark sheet;

- b) **Admission confirmation is subject to verification of all the documents at the time of admission. If any mismatch of aggregate marks/category/other details is found in documents of the candidates, their admissions will be rejected.**
- c) Candidates has to make online payment of fees of **Rs. 57,465/-** (Rupees Fifty Seven Thousand Four Hundred and Sixty Five) **after submission of above-mentioned documents** to the college office through online payment (Debit Card / Credit Card / Internet Banking). The link for the payment will be emailed to the eligible candidates after verification of documents.
- d) Candidates are requested to set the transaction limit with their bank portal/app to avoid delay in payment of admission fee.
- e) Easy Monthly Instalment facility (3 to 12 months) is available through GrayQuest with the rate of interest. Please read the FAQs provided by the GrayQuest for Online Payment and EMI Payment Options.
- f) Candidates will receive Online Fee Receipt through the system on their email ID within a week from the online payment of fee.

Cancellation of Admission and Refund of Fees:

If the candidate applies for Cancellation of Admission before the cut-off date, Rs.1,000/-will be deducted as a Processing charges and return the remaining fees.

Please note that no refund of fee will be given to the candidates for cancellation of admission after cut-off date of admission i.e. Tuesday 31st December, 2024.
