#### DISCUSSION ON- "LINGUISTICS IN INDIA"

Objective was to facilitate a discussion on languages, issue of them being endangered and the importance of their preservation.

The discussion commenced with a presentation given by Ms. Aashi Shah, Ms. Nipa Dharod and Mr. Agneya Gopinath. The relevant constitutional and legal provisions pertaining to language in India include Articles 29, 120 and 210. It also includes Part XVII of the Indian Constitution which covers Official Languages. Towards the end of the discussion, certain participants also addressed the importance of fluency in a regional language.

#### DISCUSSION ON- " TOOLKIT CONSPIRACY: WHAT IS IT AND WHY IS IT RELEVANT"

Objective was to have an insightful discussion on the "Toolkit Conspiracy", its relevance and the events that culminated it.

The discussion began with a brief timeline of the pertinent events right from the proposal of the three farm laws to the interim bail granted by the courts. The contours of a toolkit were discussed. The charges against Disha Ravi were discussed. The Hon'ble Delhi HC opined that the circumstantial evidence was inadequate and there was no Catena between the zoom call and January 26 violence. Some facts ancillary to the entire protest movement were discussed. The speaker concluded her eloquent presentation with an eloquent thought- "Is democracy conditional".

#### DISCUSSION ON- "OTT 2021 GUIDELINES"

Another point of discussion was that the main objective of the IT Rules 2021 was to create a single regulatory framework for OTT platforms under the IT Act 2000.

A brief and interactive session was conducted to review the pros and cons of Government of National Capital Territory of Delhi (Amendment) Bill,2021. An in-depth discussion was held to review the case of Government of NCT of Delhi versus Union of India & Another. The session also aimed to clarify the Existing Polity in the National Capital of Delhi.

The Government of National Capital Territory of Delhi (Amendment) Bill, 2021 was introduced in Lok Sabha on March 15, 2021. The Bill amends the Government of National Capital Territory of Delhi Act, 1991. The Act provides a framework for the functioning of the Legislative Assembly and the government of the National Capital Territory (NCT) of Delhi.

#### AMBEDKAR JAYANTI CELEBRATION

The webinar hosted by Mr. Dipankar Kamble, author of "Dewaji— Making of an Ambedkarite Family", focused on the increasing relevance of Dr. Ambedkar in the current time. The guest speaker also discussed the two-generational struggle and offered a glimpse of the socio-economic condition of a Dalit. The discussion was engaging and full of different perspectives and opinions.

#### DISCUSSION ON- "IS SEDITION RELEVANT"

The event was conducted with the objective to facilitate a discussion on sedition, its history and constitutionality of Section 124A in contemporary times.



Speaker commenced the discussion with a small and insightful presentation and explained the meaning of sedition and disaffection as enshrined in Section 124A of IPC. The speaker then dwelled into the historical timeline of sedition. Committee was in consensus that sedition can be a tool of intimidation that is deemed important for functioning of the government. The meeting ended with the idea that irrespective of the supposed benefits of Section 124A, there is a pressing need to amend it and to subdue the vagueness of the law, and to use it very cautiously, only in the cases where the alleged seditious words have met a violent consequence.

#### DISCUSSION ON - CONSTITUTION&LITY & FAIRNESS OF THE COLLEGIUM SYSTEM IN INDIA

Resource Person – Dr. Namita Nimbalkar and Dr. R.K. Anand.


Objective was to commemorate the birth of Mahatma Gandhi and his thoughts, life and his principles.
