



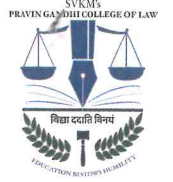

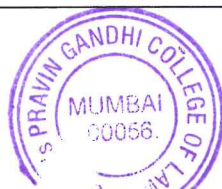
Minutes of the meeting of the IQAC held on 3rd August 2022, in the Seminar Room, Library, at 1:30 p.m.
