### Welcome & introductory remarks by the Convener:

The IQAC Convener welcomed everyone. The meeting commenced at 1:30 p.m.

The following matters were discussed with respect to the agenda:

Item I: Read and confirm the minutes of the meeting held on 12 December 2020

The minutes of the previous meeting were read by Ms Apurva Thakur and the same were confirmed by the Convener.

Item II: Review the Action Taken Report of the A.Y. 2020-21



The Action Taken Report for the Academic Year 2020-21 was reviewed by all the members, and the convener gave necessary approvals and confirmations.

- In continuation of the Cell's initiatives towards addressing mental health and wellbeing of the all stakeholders, especially in the backdrop of the changing classroom dynamics due to the pandemic, the members suggested that more programs and activities should be held to create more mental health awareness.
- The members identified most significant areas for initiatives for the A.Y 2021-22: Environmental
  awareness; to increase environmental sensitivity and citizen responsiveness; Counseling. The
  Convener suggested that activities in the proposed areas should be carried out before the end of
  this academic year.
