2. **Is college approved by the Bar Council of India?**

*Yes w.e.f. 2004 onwards.*
3. **Which University is the college affiliated to?**

*University of Mumbai*
4. **Is the college Aided?**

*PGCL is Unaided/Self-financed Minority Institution as declared by Govt. of Maharashtra*
5. **Is B.L.S. LL.B. & B.A. LL.B. both are same program?**

*The University of Mumbai has amended only the program title from **B.L.S. LL.B. to B.A. LL.B.** w.e.f. A.Y. 2022-23.*
6. **What is the intake capacity?**

*120 seats (60 students per division)*
7. **What is the fee for the first year B.A. LL.B. course for A.Y. 2025-26?**

*Fee Regulating Authority (FRA), Govt. of Maharashtra approves the academic fee for the affiliated colleges. For the A.Y. 2025-26, the fee is yet to be declared by the FRA. For the A.Y. 2024-25, the FRA had approved the fee of Rs.83,500/- every year till the completion of course.*
8. **Is students hostel available for the students?**

*No. PGCL do not offer any hostel or PG facility for the students.*
9. **Is Railway Concession facility available for the students?**

*Yes. As per age and other criteria fixed by railway authority, local train concession is available in monthly and quarterly passes.*
10. **What is the eligibility criteria for B.A. LL.B. (Five Years) admission ?**

*Forty-Five Percent (45%) marks in Aggregate with Non-Zero CET Score by State CET Cell, Govt. of Maharashtra. Candidates are advised to read the Information Brochure for Centralized Admission Process (CAP) of First Year of Five Year Degree Course for Academic Year 2025-26.*
11. **Which entrance examination is mandatory for admission to B.A. LL.B. (Five Years)?**

*Common Entrance Test (CET) conducted by State CET Cell, Maharashtra is mandatory for Five Year Law Course admission. No other entrance examination is considered by State CET Cell.*
12. **Which authority regulates the admission for B.A. LL.B. (Five Years)?**

*State CET Cell, Govt. of Maharashtra*

**21. What will be the dates of admission for first year B.A. LL.B. admission?**

**22. Is there any brochure available for the admission process?**

*Information Brochure for Centralized Admission Process (CAP) of First Year of Five Year Degree Course for Academic Year 2025-26 will be available on CET portal. Candidates are advised to download and read the CAP Information Brochure carefully before filling in the On-Line Application Form.*

**23. When should candidate report to the college for the admission?**

*Candidate Should report to the college after allocation of seat by CET Cell in the Provisional Allotment Letter in the candidates' login.*

- 24. When admission can be rejected by the college/CET Cell ?**  
*In case of mismatch of aggregate marks/category/other details with the Merit List issued by the CET Cell, admission will be cancelled by the college.*
- 25. Whether original documents will be submitted at the time of admission?**  
*Yes. All original documents will be in the custody of college till the completion of final verification conducted by the Admission Regulating Authority, Govt. of Maharashtra. Candidates are advised to keep sufficient photocopies with them to avoid inconvenience.*
- 26. Does college have institutional round after CAP rounds ?**  
*Yes. The Institutional round will be conducted after all CAP rounds in which merit list is prepared through CET portal and the admission will be given as per inter-se merit.*
- 27. Does college provide offline admissions?**  
*No. All merit lists are displayed on the college website.*
- 28. After completing admission process, when shall the candidate report to the college for regular lecture ?**  
*The college begins the regular lectures after completing all admission rounds. The notice for induction/orientation and regular lecture will be emailed by the college to the admitted candidates.*
- 29. What is the lecture timing for B.A. LL.B. classes?**  
*Lecture commences from morning 8.00 am to 1.30 pm (Except Sunday and Public Holidays).*
- 30. Does college organise Moot Court Competitions, Debate Competition, Guest Lecture, Workshop/Seminar, etc.**
