#### **BRIEF HISTORY AND DEVELOPMENT OF THE COLLEGE:**

SVKM's Pravin Gandhi College of Law (PGCL) established in the year 2004, offers a 5-year integrated law program - B.A./LL.B, Masters of Law (LL.M) and Post Graduate Diploma in Cyber Laws and Information Technology affiliated to the University of Mumbai. The blended learning approach, combined with a contextualized methodology, helps students strengthen their theoretical foundation, while gaining exposure to the practical aspects too. A brief overview of the activities bears testimony to the broad canvass of curricular and co-curricular opportunities at PGCL. The college under various committees hosts a range of intra-college and intercollegiate events, such as moot court, trial advocacy, debates, PIL drafting, contract drafting, and judgment writing. The literary events - book club meets, quiz competitions, monthly newsletters and annual issue - also reflect the literary and critical acumen of our students. The cultural committee, the sports committees through varied activities also aim at students' holistic development. Over the years, the college has introduced subject-specific committees, namely, Centre for Constitutional Law and Policy (CLPRS), Society of International Law and Affair (SAIL), Centre for Corporate Laws and IPR (CCLIPR), Criminal Law Forum, Centre for Conflict Resolution, Consumer Advocacy Centre. To make our students adept professionals, and to prepare them for their future career prospects, an Experiential Learning Program (ELP) is conducted for final year students, providing practical experience in an array of law firms and many other corporate organizations.
