About the Conference:

One of the foundational questions that law grapples with is: 'What should one do?' The determination of right or wrong is inextricably intertwined with principles of ethics, which provide a set of guiding principles that influence individual and collective decisions and attempt to balance personal conduct with societal good. While law enforces rules that govern behaviour and uphold societal order, ethics addresses the moral compass that guides all human decisions.

This intersection of law and ethics invites critical inquiry into their dynamic relationship. Do ethics shape the foundation of certain laws? For example, how do notions of right and wrong inform those laws that address human rights? Conversely, can some laws challenge the moral fabric of a society as seen in the dabates surrounding euthanasia, abortion, or marital rape? How do legal systems address grey areas, when an act is unethical but legal, or when an act is legal but morally contentious? These complex questions demand an interdisciplinary inquiry.

In today's world, these dilemmas are further aggravated by global challenges such as issues relating to environmental protection, poverty alleviation, advancements in technology, and other socio-political concerns. For instance, the rapid rise of Artificial Intelligence (AI) raises ethical concerns about privacy, preference, and accountability. Similarly, the refugee crisis poses pressing questions about displacement, migration, and the ethical obligations of sovereign states to protect vulnerable populations. The deliberations on such complex ethico-legal issues through a multifaceted lens that incorporates perspectives from varied disciplines, such as anthropology, sociology, philosophy, political science, theology, literature, cinema, journalism, and other such areas of study, will facilitate a meaningful discourse. The proposed conference aims to explore how laws and ethics influence human behaviour, uphold justice, and balance individual interests with those of society, while grappling with the inherent tensions between legality and ethicality.

Submission Details:

Abstract

- Abstract length: 500 words. Abstract must contain the Name and email of the author, list of references, 3 keywords, and the working title of the paper.
- Two co-authors are allowed.
- Abstracts must be only uploaded on the Link given below
- Abstracts will be considered only after the fee payment

Paper Presentation:

- Selected papers will be called upon to make a 15minute presentation at the conference. Papers may be presented in-absentia (online) on request.
- A 'Best Paper Presented' certificate will be awarded to the best presenter.
- Abstracts not selected for presentation are free to attend the Conference and will be given a Certificate of Participation.

Publication:

- There will be a two-step review process for paper selection and publication.
- Only selected papers will be published.
- Only papers that strictly adhere to the guidelines will be published in a book with an ISBN number.
- Plagiarism must be below 10% as per institutional checks.
- Only original, unpublished papers may be submitted. Language: English, File Type: MS Word, Document Font: Times New Roman, Size: 12, Footnotes: 10.
- Length: Min. 3000 words- 6000 words.
- Citations are essential, and footnotes must be in the format of Harvard Bluebook 19th Edition.
- The paper must be coherent and grammatically correct.

To Note:

- The final selection of papers will be at the sole discretion of the organizers. Those papers that do not conform to academic standards will not be selected for publication.
- A certificate and an e-book of abstracts will be given to all paper presenters.
- An e-book will be provided to all participants.
- A print copy of the ISBN Book will be sent only to the authors whose papers are published.
- No refunds will be made.
