[A] Procedure for seeking Admission under Freeze Option:

- a) Candidates allotted SVKM's Pravin Gandhi College of Law as their **First preference [Auto Freezed]** and **candidates who have allotted SVKM's Pravin Gandhi College of Law other than First Preference and wish to freeze and do not wish to participate in further CAP rounds** shall accept the offered seat by paying Seat Acceptance Fee Rs.1,000/- through Candidate's login as per State CET Cell, Mumbai Notice No.1 dated 25th July, 2025.
- b) **Candidates are required to register** for Academic Bank of Credit [ABC/APAAR ID] - a unique 12-digit code through <https://www.abc.gov.in/>.
- c) Candidates are required to fill in Online Anti-Ragging Undertaking with the portal <https://antiragging.in/>. The steps are also available on college portal for ease of reference.
- d) Candidates are requested to fill in the College Online Admission Form with the help of CAP Application Number starting from L52_____. The link for the College Online Admission Form is as under:

- g) **In case of mismatch of aggregate marks/category with the Merit List issued by the CET Cell, admission will be cancelled by the college.**
- h) Candidates has to make online payment of fees of **Rs.94,500/-** (Rupees Ninety Four Thousand Five Hundred) **after submission of above-mentioned documents** to the college office through online payment (Debit Card / Credit Card / Internet Banking). The link for the payment will be emailed to the eligible candidates after verification of documents.
- i) Easy Monthly Instalment facility (3 to 12 months) is available through GrayQuest with the rate of interest. Please read the FAQs provided by the GrayQuest for Online Payment and EMI Payment Options. **Candidates who wish to apply for EMI facility are requested to complete the admission process at the earliest to avoid delayed payment.**
- j) Candidates will receive Online Fee Receipt through the system on their email ID within a week from the online payment of fee.
- k) **Parent-Teacher Interaction:** Candidates should meet the teacher along with their Parent or Local Guardian before taking admission to the college.
