- d) **Candidates are required to register** for Academic Bank of Credit [ABC ID] a unique 12-digit code through https://www.abc.gov.in/.
- e) Original marksheets of candidates other than Mumbai University will be kept and returned after the confirmation of admission by the University of Mumbai.
- f) Scanned, unclear, laminated and attested photocopies will not be accepted at the time of admission.
- g) Non Refundable processing fees of Rs. 100/- (+GST) per application has to be paid at the time of submission of form (online) / at the time of submission of documents, failing which the application will not be considered for merit list.
- h) Incomplete forms will be rejected.
- i) Admission form is accepted on provisional basis subject to the verification of the photocopies with the original documents at the time of admission. If any discrepancy is found in documents of the candidates, their admissions will be stand cancelled.
- j) Candidates need to make payment of fees of **Rs. 15,000/-** (Rupees Fifteen Thousand) through online payment (Debit Card/Credit Card/Net Banking) **after submission of documents** to the college office.
