No application form or request letter will be entertained after 14th August, 2025:-

- 1. Application Form (Annexure-A);
- 2. Original No Objection Certificate (NOC) from current institution/college;
- 3. Photocopy of Marksheets of Lower Examinations / result sheet signed by the Principal with seal of the college [Conversion Certificate is mandatory if marks are awarded in grades/credits];
- 4. Photocopy of Maharashtra State CET Score card;
- 5. Photocopy of Provisional Seat Allotment letter issued by the State CET Cell;
- 6. Photocopy of University of Mumbai Eligibility Certificate (Other than University of Mumbai candidates);
- 7. Gap Certificate (Affidavit on Rs.100 Stamp Paper, if applicable).

Please note that student can apply to only one college for transfer admission subject to availability of seats. Candidates admitted under J & K quota and EWS are not entitled for transfer admission.

Transfer Admission Merit List will be displayed as per schedule of **Directorate** of **Higher Education**, **Maharashtra State**.
