- e) Candidates are requested to set the transaction limit with their bank portal/app to avoid delay in payment of admission fee.
- f) Easy Monthly Instalment facility (3 to 12 months) is available through GrayQuest with the rate of interest. Please read the FAQs provided by the GrayQuest for Online Payment and EMI Payment Options.
- g) Candidates will receive Online Fee Receipt through the system on their email ID within a week from the online payment of fee.

#### **Cancellation of Admission and Refund of Fees:**

If the candidate applies for Cancellation of Admission before the cut-off date, Rs.1,000/-will be deducted as a Processing charges and return the remaining fees.
