- b) Candidate need to submit **Transfer Certificate** who have passed from the University of Mumbai or **Migration Certificate** who have passed other than University of Mumbai on **or before 14th August, 2026**.
- c) Admission confirmation is subject to verification of all the documents at the time of admission.
- d) **Candidates seeking admission to First Year LL.M. program are required to meet the College Admission Committee before taking admission to the college.**
- e) Candidates has to make online payment of fees of **Rs.66,815/-** (Rupees Sixty Six Thousand Eight Hundred and Fifteen) **after submission of above-mentioned documents** to the college office through online payment (Debit Card/Credit Card/UPI/ Internet Banking). **The link for the payment will be emailed to the eligible candidates after verification of documents.**
- f) Candidates are requested to set the transaction limit with their bank portal/app to avoid delay in payment of admission fee.
- g) Easy Monthly Instalment facility (3 to 12 months) is available through GrayQuest with the rate of interest. Please read the FAQs provided by the GrayQuest for Online Payment and EMI Payment Options.
- h) Candidates will receive Online Fee Receipt through the system on their email ID within a week from the online payment of fee.

Cancellation of Admission and Refund of Fees:

If the candidate applies for Cancellation of Admission before the cut-off date, Rs.1,000/- will be deducted as a Processing charges and return the remaining fees.

Please note that no refund of fee will be given to the candidates for cancellation of admission after cut-off date of admission i.e. Saturday 25th July, 2026.
