- b) Candidate need to submit **Transfer Certificate** who have passed from the University of Mumbai or **Migration Certificate** who have passed other than University of Mumbai on **or before 31st August, 2026.**
- c) Admission confirmation is subject to verification of all the documents at the time of admission.
- d) **Candidates seeking admission to 'Post Graduate Diploma in Cyber Law and IT' program are required to meet the College Admission Committee before taking admission to the college.**
- e) Candidates has to make online payment of fees of **Rs.15,000/-** (Rupees Fifteen Thousand) **after submission of above-mentioned documents** to the college office through online payment (Debit Card/Credit Card/UPI/ Internet Banking). **The link for the payment will be emailed to the eligible candidates after verification of documents.**
- f) Candidates will receive Online Fee Receipt through the system on their email ID within a week from the online payment of fee.
